(iii) The treated effluent shall be recycled to the maximum extent and should be reused within the premises for gardening etc. Quality of the treated effluent shall meet to the following general and specific standards as prescribed under Environment (Protection) Rules, 1986 and applicable to the unit from time-to-time :-

(ii) Quarterly compliance report of the CCA, photograph of ETP/APCs/Waste Storage Area.

5. Competent Authority reserves the right to change/modify/add any time any condition of this CCA.

6. Unit has to comply with the following specific & general conditions. Non compliance of any provision of this CCA and provisions of the Water Act, Air Act and Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016 will result in legal action under the aforesaid Acts and Rules.

7. In compliance to the G.O 1011/81-7-2021-09 (Writ)/2016 dated 13.10.2021 issued by Department of Environment, Forest and Climate Change, Uttar Pradesh. You are directed to develop Miyawaki Forest as per the SOP available at URL:-<http://www.upecp.in/TrainingSession.aspx> for ensuring timely compliance of this direction, you are hereby directed to submit a bank guarantee with minimum validity of one year of the amount equivalent to the sum of initial consent fees (Air and Water) or Rs. 50,000/- (Rs. Fifty Thousand Only) whichever is more, within 30 days from the date of issuance of this certificate. In case of non-compliance of this direction, your consent will be revoked by the Board.

8. If the unit uses the ground water and requires the permission from SGWA/CGWA for water abstraction then the industry will have to obtain No objection certificate for abstraction of ground water. It will be the responsibility of the industry to comply with the various conditions of the NOC obtained from the competent authority and submit to the Board, within 3 months time failing which CTO will be revoked.

#### **General Conditions:-**

1. The applicant shall get analysed the samples of effluent/emission/hazardous wastes at least once in a three month from the laboratory recognized by the MoEF and shall report to the UPPCB.

2. The applicant shall however, not without the prior consent of the Board bring into use any new or altered outlet for the discharge of effluent or gases emission or sewage waste from the unit.

3. Treated Industrial waste water and domestic waste water shall be disposed jointly at one disposal point. The applicant shall provide discharge measurement equipment at final disposal point.

4. The applicant shall strictly comply with conditions of this CCA and submit compliance report of stipulated conditions within 30 days of receipt of this CCA. If at any point of time, it is found that the industry is not complying with stipulated conditions or any further direction/instruction issued by the Board, legal action shall be initiated against the applicant.

5. The applicant shall maintain good house keeping. All valves/pipes/sewer/drains etc. must be leak-proof

6. The industry shall provide uninterrupted entry to the STP/ETP inlet and outlet points, Air Pollution Control equipment and stack for smooth sampling/monitoring of efficiency of pollution control systems.

7. The industry shall provide Inspection Book at the time of inspection to the Board's officials.

8. Whenever due to any accident or other unforeseen act or event, such emission occurs or is apprehended to occur in excess of standards laid down, such information shall be reported to the Board's offices and all other concerned offices. In case of failure of pollution control equipment, the production process connected to it shall be stopped with immediate effect.

9. The industry shall operate in a manner so that all emissions be emitted through designated chimney/stack only.

10. In case of any damage to the agriculture productivity, human habitation etc. by the operation of industry, it shall be imperative to stop production in the industry with immediate effect and such information shall be reported to Board's offices. The industry shall be liable to pay compensation also in such cases as decided by the Competent Authority.

11. The applicant shall apply before the 60 days of expiry of CCA or any change in production types/production capacity/manufacturing process/capacity enhancement etc. or any change in effluent discharge point or emission point

12. The Board reserves the right to revoke/add/modify any stipulated condition issued along with CCA, as may be necessary.

**Specific Conditions:-**

1. This consent to operate is granted for M/s INDIRA IVF HOSPITAL PVT. LTD., D-63/7 C10, MEHMOORGANJ, DISTRICT-VARANASI for health care facility.
2. This CTO order is valid from dt. 01.04.202023 to dated 31.03.2026 for health care facility-10 beds.
3. HCF shall abide by directions given by Hon'ble Supreme Court, High Court, National Green Tribunal, Central Pollution Control Board and Uttar Pradesh Pollution Control Board for protection and safeguard of environment from time to time.
4. The HCF shall comply the provisions of Environment (Protection) Act, 1986 and Biomedical Waste Management Rules, 2016 as amended.
5. Compliance report of the consent order must be sent to this office at the earliest.
6. The HCF shall ensure the regular operation and maintenance of E.T.P./S.T.P so that it meet the stipulated norms of effluent discharge.
7. HCF shall obtain prior approval before making any modification in the bedded capacity of the hospital.
8. The HCF shall install adequate capacity of E.T.P./S.T.P within three month for treatment of waste water.
9. The HCF shall maintain logbook for the fresh water consumption & treated domestic sewage discharge.
10. The HCF shall keep good housekeeping and proper handling, collection and safe disposal of municipal solid waste as per provisions of MSW Rules, 2016.
11. Raw sewage & treated sewage shall be get analyzed by NABL accredited laboratory/U.P. Pollution Control Board at regular interval and submit the test report in this office.
12. The Board reserves its right to modify the above conditions or stipulate any additional conditions including revocation of this order in the interest of environment protection.
13. The HCF shall install roof top rain water harvesting system within two months.
14. The HCF shall obtain permission for ground water abstraction from CGWA.
15. The HCF shall submit the balance sheet/CA certificate for verification consent fee. On the basis of audited balance sheet/C.A. certificate if consent fee due in that condition balance amount of consent fee shall be deposited by HCF.
16. HCF should ensure to submit approved map and land use from local competent authority for the use as Health care facility within one month failing which your authorization certificate treated as cancelled.
17. The HCF shall ensure that house-keeping of premises is to be good always. The HCF shall ensure that the handling, collection and disposal of bio medical waste should be in proper and safe way.
18. The D.G. set should have minimum stack height 0.2x KVA from roof-top of the nearest building with acoustic enclosure and monitoring of noise level, stack emission and ambient air quality should be done by the laboratory recognized under Environment (Protection) Act, 1986 and report be sent to the Board.
19. This Consent of the HCF is automatically considered abrogated after receiving public grievances regarding air pollution against the industry and the confirmation of the complaint by UPPCB.
20. Industry shall comply the provisions of Environment (Protection) Act, 1986, Air (Prevention and Control of Pollution) Act, 1981 (as amended), Water (Prevention & Control of Pollution) Act, 1974 as amended and Bio-medical Waste Management Rules, 2018 (as amended)
21. The unit shall obtain NOC from Ground Water Department for abstraction of ground water within 03 months and shall be submitted to State Board.
22. The Unit shall install rain water harvesting system as per guidelines.
