

5. This authorization is subject to the conditions stated below and to such other conditions as may be specified in the rules for the time being in force under the Environment (Protection) Act, 1986.

Terms and conditions of authorization *

- The authorization shall comply with the provisions of the Environment (Protection) Act, 1986
- The authorization or its renewal shall be produced for inspection at the request of an officer
- 3. The person authorized shall not rent, lend, sell, transfer or otherwise transport the biomedical wastes without obtaining prior permission of the prescribed authority.
- 4. Any unauthorized change in personnel, equipment or working conditions as mentioned in the application by the person authorized shall constitute a breach of his authorization.
- 5. It is the duty of the authorized person to take prior permission of the prescribed authority to close down the facility and such other terms and conditions may be stipulated by the
- The Bio- Medical waste shall be segregated into containers or bags at the point of generation in accordance with schedule I prior to its storage, transportation, treatment.
- 7. The containers or bags referred to in sub-rule (2) shall be labeled as specified in schedule IV.
- s. The occupier shall ensure that bio- medical waste generated in hospital is handled without any adverse effect to human health and the environment.
- 9. If a container is transported from the premises where bio-medical waste is generated to any waste treatment facility container shall, apart from the label prescribed in schedule IV, also carry information in schedule IV.
- Bio-medical waste shall not be mixed with other waste.
- 11. No untreated bio-medical waste shall be kept beyond a period of 48 Hrs. If it becomes necessary to store beyond 48 Hrs. The authorized person must take permission from the prescribed authority to ensure that it does not adversely affect human health and the
- 12. The occupier shall submit an annual report to the prescribed authority in form IV by 30th June every year, to include information about the categories and quantities of Bio-medical waste handled during the preceding year.
- 13. This authorization shall be valid subject to the validity of agreement with the Common Bio Medical Waste Treatment Facility. Renewed agreement should be submitted before the expiry of existing agreement.
- 14. The occupier shall maintain a record to the generation, collection, reception, storage, transportation, treatment, disposal and or any form of Bio-medical waste in accordance with these rules and verification by the prescribed authority at anytime.
- 15. The occupier shall ensure the Mercury Spillage Management within the Hospital/Nursing Home etc due to breakages of thermometers, pressure & other measuring equipments as the spilled mercury does not become part of bio-medical or other solid wastes generated from the health care facilities.
- Bar code system for bags or container containing bio-medical waste to be sentout of the premises or place for any purpose should be submitted within 15 days.
- 17. The occupier shall ensure that waste water generated from the hospital shall be treated as per norms and should obtain consent to operate, under provision of Water (Prevention & Control of Pollution) Act,1974 Under section 25/26 and Air (Prevention & Control of Pollution) Act, 1981 under section 21/22.
- 18. It is within powers and function of the U.P. Pollution Control Board to modify/revoke the terms and conditions of the authorization issued under the Bio-medical waste Management Rules, 2016.

THIS AMENDMENT TO BIO-MEDICAL WASTE MANAGEMENT SERVICE AGREEMENT (the "Amendment") is made vide registration no. CGHA00004665 and entered into as of 02-Feb-22

WHEREAS, this Amendment amends that certain BIO-MEDICAL WASTE MANAGEMENT SERVICE AGREEMENT dated 30-January-2021 (the "Agreement") entered by and between Operator, and Generator; and

WHEREAS, the Parties desire to extend the term of the Agreement for an additional term, and WHEREAS, the Parties desire to further amend the Agreement as specified in this Amendment;

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties hereto agree that the foregoing recitals are incorporated herein by reference and as follows:

- 1. Except for the provisions of the Agreement specifically addressed and modified in this Amendment, all other provisions of the Agreement shall remain in full force and effect.
- 2. Capitalized terms used but not defined in this Amendment shall have the meaning ascribed to such terms in the Agreement.
- 3. The Agreement is hereby renewed and extended for an additional term of ONE years, commencing on 01/02/2022, and concluding on 31/01/2023 ("Renewal Term No.1")







4. Rates are revised from INR 1,000.00/- to INR 1,100.00/- per month Period from 01/02/2022 to 31/01/2023;

Subject to the condition of maximum weight limit of 10 kg per month. The quantity of BMW over & above the limit shall be charged @ Rs. 30 per kg. The service charges mention herein is applicable for the declared capacity of 0 (NIL) beds only.

- 5. The Amendment shall be effective as of 01/02/2022
- 6. This Amendment constitutes the entire agreement between the Parties regarding the subject matters specifically contained herein and may be amended or modified only by a written instrument signed by each of the Parties.
- 7. This Amendment supersedes any other prior agreements or understandings of the Parties relating to the subject matter specifically contained herein and the Parties are not relying on any statement, representation, promise or inducement not expressly set forth herein.
- 8. This Amendment shall be governed by and construed in accordance with, the laws of the Republic of India and the courts of Ghaziabad shall have the exclusive jurisdiction. Any disputes arising out of this Amendment shall be dealt in accordance with the mechanism governing the Agreement.
- 9. This Amendment may be executed in one or more counterparts, and in both original form and one or more photocopics, each of which shall be deemed to be an original, but all of which together shall be deemed to constitute one and the same instrument.
